MEMBERSHIP CONTRACT - 2026 Season RULES AND REGULATIONS

A) GENERAL RULES

1. Membership fees must be paid in full before membership privileges can be enjoyed.
2. Each member is required to log in to the pro shop before each round (15 minutes before the start time).
3. Membership cards are non-transferable.
4. The subscription will not be refunded under any circumstances.
5. The golf club must be informed of any changes of address.
6. A member who arrives at the first tee without a reservation must register at the pro shop.
7. Members may only tee off from tee #10 with the permission of the starter or the pro shop.
8. The opening hours and days of the golf club may be changed or modified at any time by the management of Arundel Golf & Country Club Inc.
9. The Golf Club reserves the right to close a section of the course to carry out repairs or host outside functions.
10. Each member agrees to abide by their membership restrictions and to follow proper golf etiquette.
11. Each member agrees to comply with the Club's rules and regulations as posted for all customers.
12. Members assume full responsibility for their guests, including their conduct, compliance with all rules, payment of fees, and any damage caused. Any breach by a guest will be considered a breach by the member.
13. All players must maintain a proper pace of play. Club staff and marshals are authorized to intervene, regroup players, restrict access, or expel any person whose conduct interferes with play, safety, or the proper operation of the course.
14. Members and their guests must not publish or disseminate false, misleading, defamatory, or malicious statements about the club, its employees, its members, or its operations, whether in person, in writing, or on social media, including personal accounts. Any such behavior will constitute a breach of the membership terms and conditions and may result in disciplinary action, including suspension or revocation of membership, without refund.
15. It is strictly forbidden to enter the Arundel Golf & Country Club property with alcoholic beverages and food.
16. Arundel Golf & Country Club Inc. may, at its sole discretion and without obligation to provide justification, suspend or revoke any membership without refund for misconduct, unsafe behavior, intoxication, abuse of staff or members, or repeated violations of Club rules.
17. Arundel Golf & Country Club Inc. reserves the right to cancel or revoke any membership.
18. Members are permitted to book tee times 30 days in advance. Non-members are permitted to book tee times 14 days in advance. Arundel Golf & Country Club reserves the right to open reservations for non-member groups at its discretion. Arundel Golf & Country Club reserves the right to change tee times if necessary and to notify affected members up to 72 hours prior to the confirmed tee time. Players may be required to be grouped with other players to form foursomes if such circumstances exist. In all cases, the configuration of groups will be at the discretion of club officials. Any group missing their tee time will lose their place and will have to wait for the next available tee time.
19. For all cancellations within 24 hours of the tee time or any "no shows," The Arundel Golf & Country Club Inc. reserves the right to charge the daily rate to your account for the number of players reserved at its discretion. Example: for one member and three guests, a four-day rate will be charged to the member's account. In case of rain, you must call on the morning of your tee time to check the weather conditions on site. If the weather is good, you must respect your tee time. All members are responsible for their reservations and cancellations, and we ask that you give preference to online reservations. A member cannot make or cancel a reservation for another member.
20. Caddies: A maximum of 2 caddies is allowed per foursome. Members who purchase unlimited green fees or green fee packages have only paid for their portion of the green fee, so anyone riding with them must have a green fee package or have paid the required fee at the Pro Shop.

B) PAYMENT OF ACCOUNTS

1. All balances due to the Club unpaid for thirty (30) days may result in suspension of playing privileges or possible expulsion from the Club.
2. The member renting or operating a golf cart assumes full liability for its use and shall be responsible for all damage, loss, or replacement costs arising from misuse, negligence, or failure to comply with Club policies. Such costs may be charged directly to the member's account.

C) RULES OF THE CHAMBER

1. It is prohibited for a member to personally reprimand an employee. Complaints relevant to employees must be filed in writing directly with the Club Manager.

D) THEFT/DAMAGE

1. It is forbidden to leave money or valuables in locker rooms or storage areas of golf clubs. Arundel Golf & Country Club Inc. disclaims any liability for theft or damage to the property of its members, their families, or guests that occurs inside or outside the golf club.
2. This limitation does not apply to damage caused by misuse of Club equipment, including golf carts, which remains the responsibility of the member.

E) DISCLAIMER - PROPERTY OR INJURY

1. Course closures, weather delays, frost, maintenance, operational restrictions, or reduced services shall not entitle members to any refund, credit, compensation, or extension of membership.
2. In no event shall Arundel Golf & Country Club Inc. and its staff be liable for any injury to members, their families, or guests, howsoever caused, occurring on Club property, or for loss of or damage to property, whether by theft, fire, or other cause.
3. The Club shall not be liable for any interruption, limitation, or suspension of services resulting from events beyond its reasonable control, including but not limited to weather events, natural disasters, governmental actions, or labor disruptions.
